The Volunteer understands and acknowledges that this Release discharges the City of Superior WI and the Nonprofit 501c3 organizations from any liability or claim that the Volunteer may have against any of for mentioned with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the activities involved in volunteering for the Superior Public Museums, GLSPS, LSMMA, or WUAA. The Volunteer also understands that, except as otherwise agreed to by the City of Superior WI, GLSPS, LSMMA, and WUAA in writing, the above mentioned entities do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.
